- BSPAA in force
- Four directives issued
  - Procurement
  - Expenses
  - Perks
  - Reporting
  - "Guidebook" and "Toolkit"

- January 1, 2012
  - "publicly funded" organizations in
  - FIPPA applies to hospitals

# GUESS WHAT? NO NEW MONEY TO DEFRAY NEW COSTS!

#### Procurement Directive

- Sources of concern
  - AIT application (sn. 5)
  - Documenting "exceptions" (sn. 5)
  - What is a "consultant"? (M-3)
  - Not using "Contract A" (M-16)
  - Seeming rigidity (64 musts)

#### **Expenses Directive**

- Sources of concern
  - Never meals/snacks/beverages (V)
  - Must be in contract (V)
  - No hospitality (H)
  - Costs are masked (V, H)

#### LEADS AWAY FROM "TRANSPARENCY"



### Perquisites Directive

- Sources of concern
  - Overrides contracts (sn 2)
  - Some loss of value to H
  - Loss of respect for office/H

## EVERYTHING PAINTED WITH THE SAME BRUSH!



#### Reporting Directive

- Sources of concern
  - No guidance on transition
  - No guidance on sanctions
  - What is "material exception" for PD?
    - 10K and up?
    - 100K and up?
    - All consultants?

### Is Anything New Coming?

- Things to look forward to
  - More experience with all directives
  - Attestations may inform
    - LHIN interpretations
    - LHIN sanctions
