Civil litigation: complex contractual disputes, torts and negligence claims, occupiers' liability, personal injury and fatalities, interim orders, and other relief.

Construction: acting for all sides regarding major public infrastructure projects and understanding project administration, contractual interpretation, and disputes involving delay, productivity, cost overruns, and workmanship claims.

Insurance defense: acting for insurers, insurance-related private businesses, and self-insured corporations in their defense of life and disability claims, construction claims, personal injury, property, and product liability.
